On August 7, 2000, the U.S. Army Corps of Engineers, Alaska District forwarded you a review copy of the document entitled "Draft Work Plan, 2000 Remedial Investigation/Feasibility Study, Northeast Cape, St. Lawrence Island, Alaska" dated August 4, 2000. The District had requested that comments be forwarded by September 6, 2000.

This is to advise that the review period will be extended; we will advise of a new date for submittal of comments. The initial review time was intended to allow for incorporation of comments and to get the contractor into the field this season. Since then, we have decided to reschedule most of the field work to the 2001 field season to assure that stakeholders have adequate opportunity for review of the work plan prior to field work taking place. We still intend to perform some sampling of buildings for asbestos and paint constituents this field season; however, the field work related to remedial investigation, risk assessment, and feasibility study issues will be rescheduled for the year 2001.
