Enclosed are responses to comments submitted on the document: Feasibility Study, Northeast Cape FUDS dated June 2006. those with e-mail, an electronic copy has been sent to you instead of an attached hard copy. A detailed response is provided to answer the questions or indicate text changes that will be made in the final document.

It is understandable that there are some general misgivings and dissatisfaction with the Department of Defense (DoD) and State of Alaska (i.e., ADEC) environmental policies as expressed in some of the commentary we received on the Feasibility Study. Whereas those policies generally mandate that cleanup actions at Formerly Used Defense Sites (FUDS) result in leaving a landscape that is protective of human health and the environment, it is not uncommon for public dissent to focus on the adequacy of investigation, and how much cleanup is enough. Hand-in-hand with that focus are opinions that cost should not be an obstacle in the cleanup effort. Please keep in mind, that FUDS goals and objectives require the Corps to implement cost-effective response actions. It is our duty and fiscal responsibility to the American people.

We know that many people believe the former Northeast Cape facility has caused St. Lawrence Island residents to suffer adverse health. There has been considerable debate on this issue. We are genuinely concerned about the environmental health of St. Lawrence Island. Though a communications facility over sixty miles away from the nearest community, and with little contamination except for hydrocarbon fuels and oils, seems an improbable source of harm for residents of Savoonga or Gambell, we seek a level of cleanup that can put the debate to rest.

The Corps of Engineers must follow existing FUDS policy. Whereas that policy may not accommodate all of the concerns at Northeast Cape, such as landfill removal, we have conducted our investigations within the flexibilities of the program. We have sought, and demonstrated, a partnership approach. We hope that any discouragement over the cleanup process does not lead to apathy. As we have stated in the past, we value your input, and it has made a difference. The opinions expressed in the comments received on the Feasibility Study will influence the final cleanup decision.
